# Excess Animal and Breeders Permit Application

Approval is required to keep more than two animals over three months of age on a town property.

### Applying for Excess Animal Permit

Non-refundable application fee of \$60. Plus registration for all animals if application is successful.

### Applying for Breeder/Kennel Permit

Non-refundable application fee of \$60. If successful an annual fee of \$135 to renew permit will be due as well as registration for all animals.

**Applications will only be approved if the assessment criteria have been met. This criteria has been written in accordance with *The Animal Management (Cats and Dogs) Act 2008*.**

### ASSESSMENT CRITERIA

We recommend reviewing the following criteria before submitting your application as it will assist you in identifying if having additional animals is suitable for your circumstances.

For **breeder permits only**. You must provide a copy of your breed society affiliation paperwork to council.

A fully enclosed area in which your animals can not escape, under, over or through the fence.

The size of the property should be appropriate for the size and number of animals. E.g. it may not be appropriate to house two 60kg dogs on a 500m<sup>2</sup> block. Please refer to table on page 2.

The existing and additional animals are not impacting or causing a nuisance or annoyance to neighbouring properties or the community.

You own the property or have a consent letter from your landlord that allows the keeping of the following animals.

You have signed attachments from neighbours stating they consent to the keeping of excess animals.

Animal waste is disposed of and dealt with in accordance with the *Environmental Protection Act 1994* and the *Water Act 2000*. You must comply with minimum standards for keeping an animal for *Local Laws No. 2 (Animal Management) Keeping of Animals 2011*.

All animals must be registered with Council and ideally microchipped and desexed.

Only keeping the animals specified within this application at the address. **Approval is not transferable and therefore would be void should any animal listed in this application become deceased or relocated to another allotment or leave the Paroo Shire area. Unless written notice has been provided to Council.**

Dogs	The number of dogs you may keep without approval is dependent on block size. This applies to dogs over the age of 3 months old. On allotments with: <ul style="list-style-type: none"> <li>an area less than 2500m<sup>2</sup> – 2 (two) dogs (up to four dogs can be kept with council approval)</li> <li>an area between 2500m<sup>2</sup> – 4000m<sup>2</sup> – 3 (three) dogs (up to four dogs can be kept with council approval)</li> <li>over 4001m<sup>2</sup> and less than 40000m<sup>2</sup> – 4 (four) dogs</li> <li>greater than 40000m<sup>2</sup> – 5 (five) dogs</li> </ul>
Cats	No more than 2 cats over the age of 3 months on an allotment in the designated town area.
